

Electronic Lodgment Declaration JobKeeper – Business Monthly Declaration

This declaration is to be completed where the business monthly declaration is to be lodged via an approved ATO electronic channel. It is the responsibility of the taxpayer to retain this declaration for a period of five years after the declaration is made, penalties may apply for failure to do so.

Privacy
